RULES & REGULATIONS

Budd Bay Courts & Cages - RULES & REGULATIONS:

Participant and family members agrees to abide by any and all rules of conduct and play set by Budd Bay Courts & Cages. Failure to do so may result in suspension from participation.

Large Team Cage Maximum: Budd Bay Courts & Cages allows a **MAXIMUM** of 12 players and 4 coaches during any session. Multiple teams are not allowed to practice during the same session.

Small Walk In Hitting Cage Maximum: Budd Bay Courts & Cages hosts 2:1 or 4:1 Hitting Clinics in that cage. OR this cage is intended for Walk In traffic only. 1 player during any Walk In Hitting session.

Upstairs Observation Area: Is meant to be a quite and safe place for parents and children to watch a practice or clinic. If your other children are not happy in a confined space - feel free to come back at the end of your scheduled session. Please keep ALL CHILDREN off of and away from the cage netting and weight equipment. It is the parents responsibility to "police" their own children and their behavior. Please be considerate of other families trying to listen to the coaches.

Players must come equipped with glove and appropriately dressed in athletic apparel, protective cup and tennis shoes. NO cleats please. Please arrive 15 minutes prior to clinic or cage rental time.

72 HOUR CANCELLATION POLICY PRIOR TO CLINIC START DATE or RENTAL DATE
Once a weekly clinic/rental has started, you will be expected to attend every session.
No refund or makeup sessions are offered.

EMERGENCY MEDICAL TREATMENT
